The wars represent the synthesis we see according to Hegel's Theory. Wars create benefits - profit, interest. According to the thesis and the intrigue are necessary for the movement of history. The truth is that both the thesis, the antithesis and the synthesis are important for the capital and the fruits of this capital - the profit. The trilateral commission openly admits that solving for war and peace is only taken by a few elite people. All property common source - Hegel.

Hegel teaches that the state is God, and the only obligation of the citizens is to serve the state, thus serving God. Historical dialectics - all historical events emerge from conflicts between opposing forces / thesis and antithesis /, but which are generated by financially resource-based technical mafia-driven materialism, adds Momchil Dobrev. Soros's ideological platform is from the great Austrian philosopher and thinker Carl Popper who prefers him in London. The idea of freedom aims to create flexible tools for powerful geopolitical influences in the individual countries of East Europe and the developing world. However, we can not only speak of self-presumption of "freedom" as Carl Popper does if these rights of freedom are not based on legal norms, ethical norms, moral norms and society. Otherwise, freedom becomes infinite and chaos of freedom and chaos for freedom.

According to Carl Popper, truth is not something that is discovered, it is invented. Ie. the truth is always temporary, it remains in force until it is rejected. Truth is in the human spirit, in the imagination and the reason of man,. The truth, according to Popper, is constantly exposed to the cross-fire of trial and experience - trying to "falsify" it as a substitute, as it has been, and inevitably, progress, civilization, will be inevitable in various stages of human development.

This is Popper's philosophy. It is limited and burdensome. That truth exists and may have a relative existence does not mean that it is relative. Truth is insecure, so science is vulnerable. But that does not mean that the truth is inaccessible. The existence of truth is evidenced by human progress in all areas: science, technology, society, politics. Popper turns criticism - ie. the exercise of freedom - the basis of progress. Without criticism, without the possibility to "falsify" all the assurances, there is no progress in science or in the fulfillment of social life. Popper says that with the simultaneous birth of the open society, in which intelligence has replaced the irrational, the individual has become a true person in history, and freedom has begun to displace the former bondage.

But here is the criticism of Prince Lord Prof. Momchil Dobrev that there can not be just freedom without the legal, ethical, moral norms on which a society is built.

Soros' ideological platform is from the great Austrian philosopher and thinker Karl Popper, who prefers him to London. 5.5/. Francis Fukuyama and The criticism of Prince Lord Prof. Momchil Dobrev to Fukuyama

The end-of-Fukuyama theory is a mixture of Hegelian metaphysics and an imitation of evolutionary theory. According to him, the liberal state associated with a market economy is the only possible alternative to communism and the real existence of a society. According to Fukuyama, liberal democracy is what is called the last form of human rule. For the first time in his book Identity, he acknowledges the possibility of liberal democracy falling or regressing. According to him, liberal democracy has not solved the problem of timos, which is part of the soul that desires recognition of its dignity. An isotomy is the desire to be treated equally with other people. And megalothymia - the desire to be recognized as superior to others. Modern liberal democracies provide a minimum amount of equal respect, human rights, the rule of law. He states that entire countries may feel disregarded, which fuels aggressive nationalism.

This is the same for religious believers.

Fukuyama makes no distinction as to which religion is just, which religion does not attack other religions, which religion does not respect other regalia, which religion is aggressive against any other faith to explain and seek recognition for recognition.

Whether one religion seeks recognition from another religion by recognizing the same religion.

He writes: "There is nothing wrong with identity politics itself. It becomes a problem when the identity is interpreted or maintained in a certain way."

Identity according to Fukuyama

Identity is a "powerful moral idea." It does not recognize borders and cultures. It is based on the universal and universal human psyche. This tells us that we have our authentic inner Self, which is unrecognized. It is restricted only to freedom of choice, which is limited and non-directional. What dignity is - and it has to do with the freedoms, the morals, the moral norms, the principles of statehood, the foundations of the moral ethical rules of a society. And they are at the heart of whether and how recognition and dignity and identity are permissible. Fukuyama views the identity of many as restrictive as a spimulus for protest, for revolution, and

others. Fukuyama does an analysis of what freedom is, and what is the framework and minimum elements of liberties that ensure the dignity and recognition of the individual and his or her identity. Ie acknowledged as a prerogative for its own sake without considering the legal and moral and ethical framework of a society, it is an end in itself, and is used by individuals and representatives of the Financial Bank Resource - Technological Mafia Materialism such as George Soros. Modernization is described as mobile, complex, flexible, and means constant upheavals and turmoil, as well as opportunities that did not exist before. But freedom and the ability to choose .. can make people feel miserable and awakened by other human beings. They can be harassed by leaders who tell them that they have been deceived and humiliated by existing power structures.... "

(Everything is blurred to seek conflict, Ie using identity to divide society, confronting groups of people with so-called% different identities. " Ie identity is formulated as different, different Blending experiences of values, lusts Experience - Erlebnis blends and merges with Erfahrung, which is incorrectly scientific. These are different Mutual respect for dignity is sought without considering the place of man in society in the relevant legal, ethical and moral norms of the respective communion and what legal, moral and ethical norms it defends.

Ie goals are divided into society, by people of identity groups, in order to manage these people through these identities Identity politics is the division of the commons, the joy; the division of people into groups by my elementary attributes - benefit, age, race, workplace, education, profession.

Promoting the fight for identity recognition - this is the same fight and directing Fukuyama to new forms of chaos and generating wars. Ham cites multiculturalism, chewing and calling for confidence in civic consciousness.

It does not look at what kind of purpose the trust is aimed at.

- A. That is why Prof. Dr. Momchil Dobrev Dobrev was born in 1991. creates a Theory of Trust.
- B. Fukuyama views civil liberties and citizenship laws as too limited as a basis for identity.
- C. It seeks to respect the fundamental principles of liberal democracy and to displace citizenship laws in individual Member States. Ie Citizenship laws are the only necessary Fukuyama identity.
- D. Fukuyama highlights the problem of privileging some ethnic groups at the expense of other groups. Ie it is not considered grounded in a community the legal moral, ethical norm and framework of a society, but it seeks to distinguish, divide, differentiate groups from ethnic groups.
- E. This is the real purpose of the conflict, the protection of ethnic groups.

- F. Ie it is fundamentally about citizenship laws, not respect, enforcement, or the laws of a society.
- G. What has been written is that different nations have different identities, which leads to different goals and interests, the purpose is conflict between different nations and peoples.

Fukuyama provides guidance on how European countries change their identities is a barrier to ethnic origin. Ie the purpose is to create different identities, to create such identities, which then contradict other identities, to enter into conflict, into confrontation. And it focuses on ideological identity. This is where the reasoning is mixed, le Equal opportunities. Provided assimilation guidance to begin in the US with education. Too simple to consider citizenship is the right to vote, not the other obligations to this community. It obliges us to owe refugees, understanding, sympathy, and support. But this obligation must also be on the other hand, - when required to respect the laws, the legal moral and current norms of society. Too one-sided viewing. Not every request for a simple look at the immigrant problem is called Fukuyama racism. Inequality. Respect and dignity are considered too simplistic by Fukuyama.

The term "identity politics" is used to create conflicts between ethnic groups, and not to analyze the entitlements and obligations given. Freedom is not only a right, but also a duty for every person to live in a community. It is no coincidence that Karl Popper views liberty too simply. Fukuyama does not consider that arrogance also means obligations, and these obligations must be fulfilled by the appropriate group with the appropriate "identity". Ie Emphasis is placed on "identity" and not on the rights and obligations under certain freedoms in a society. Ie the loss of dignity is A Is a society able to respect, recognize, to what extent, how, why the dignity of an individual or a group of individuals, but considering Dignity without analyzing it in a set of freedoms with their rights and obligations is too simplistic and does not produce any real results. Fukuyava did not consider whether the information was accessible to everyone, how, why, to what extent, or not. Fukuyama looked too limited at the revolutions in Georgia, the Orange Revolution, the Green Revolution in Iran, and the Orange Revolutions in the African countries are all too simplistic. He substantiated his thesis that after the end of the Cold War, supranational cultural and religious identities would become major source of conflict. The term civilizations appeared before 1926. in the book examining the Middle East, by Basil Mathews, Yung Islam of Trek - This term is derived from the clash of cultures,. the term is also used by Bernard Lewis in the article "The Roots of Muslim Anger" published in September 1990 in "The Atlantic Monthly - Cold peace, cold war, trade war, quasi-military, difficult peace, strained relations, fierce rivalry, competition, arms race. He makes his judgments when examining the various theories and the nature of

global politics in the aftermath of the Cold War. Human rights, liberal democracy and the capitalist economy are the only ideological alternatives to post-Cold War nations. Huntington believes that the era of ideology is over, the world is back to normal, characterized by cultural conflict. Ie His thesis that the main axis of conflict in the future will be along the lines of the cultural and religious faults. Different civilizations have different identities.

Following the predominantly proposed construct of Oswald Spengler and Arnold Toynbee, Huntington states that "human history is the history of civilizations." He also classifies the types of civilizations as follows:

- 1. Western civilization / based on Catholicism and Protestantism
- 2. Islamic civilization
- 3. Hindu civilization
- 4. Chinese civilization / based on Buddhism /
- 5. Japanese civilization / Shinto-based
- 6. Latin American civilization / based on Catholicism and local traditions
- 7. Orthodox civilization
- 8. African civilization

Every civilian wants to maintain its identity.

Most civilizations have a core state that is dominant and organizes other states in the civilization community. According to him, every civilization seeks to preserve its identity, and in many cases to extend its sphere of influence. According to Huntington, the 21st century will be an era of inter-civilizational clashes or conflicts. In reality, this is a change in the nature and causes of a particular war - be it the Cold War, the trade war, war, or other. There is a blurring of the true causes and the foundations of a war, be it and whatever its form. There is no real search for the causes of war for the ultimate purpose of gaining resources, securing flows. This is too simplistic to consider the causes of a war. Talk about fault characteristics along the fault line-First, community wars are fought between ethnic, religious, racial, or linguistic groups. Since yakao religion is the main defining characteristic of any civilization, wars are always fought between peoples from different regions. This is a replacement of the truth about who and for what reasons a war is coming. What are the motives, what are the reasons for a war, whether and who creates the occasion to provoke war. The most elemental thing is to cause conflict between different religions to use to provoke war. Or create a front and a war by creating a military base on a religious basis such as that of the ISIL, created by the CIA and aided by the CIA for conflict in Syria, Libya and other countries. The economic structure is built on the basis of the market economy, which is regulated by free competition. Liberal classics reject the possibility of state intervention. Neoliberalism recognizes state interference in economic life, but only when the state preserves and works for free competition.

Neoliberalism is the antithesis of the economic system of Keynesianism - which justifies the need for state intervention in the economic life of the country. This theory became dominant in the 1930s and 1940s after Black Friday, with economic crises in the 1970s showing that the state was a weak regulator of economic life. After World War II, neoliberalism began to play an important role in Western European countries, especially in England (London School), the United States / Chicago School /, Germany / Freiburg School /, France, Italy and Belgium. This is necessitated by the sought-after accelerated development of the countries after the Second World War.

The early 1970s saw a boom in neoliberalism in economic thought. This follows the awarding of the Nobel Prize in Economics to Friedrich von Hayek and Milton Friedman. It takes place after the abolition of excessive state interference in economic life, which is accompanied by all the resulting dangers to freedom. Neoliberals believe that the state is incapable of ensuring the well-being of all members of society, and this necessitates a limitation of its powers. Hayek and Friedman believe that proportional rather than progressive taxation is a key feature of neoliberalism. In financial policy, neoliberals uphold the principle of a balanced budget. In the field of monetary policy, the state should be deprived of its monopoly on the issuance of money. In the field of social policy, freedom, the application of antitrust laws and consumer protection measures, free initiative, guaranteeing fundamental freedoms to citizens should be limited to a minimum. The main elements are - the priority of private property, low taxes, restrictive social policy, stable money supply, limiting state intervention in the economy and anti-regulation.

Relationships between people are now seen only as competition. Neoliberalism considers competition as the only legitimate organizational principle of human society and human activity. Hayek believes that it solves the problem of modernity, the problem of operational knowledge. According to Hayek, the market legitimizes the trade in goods and services with precisely defined prices and the value of human qualities, but the market reveals only the truth. For neoliberalism, competition is the most important characteristic of human relationships. In reality, neolibaralism defines citizens as consumers whose choice is determined by buying and selling. It is the market that rewards human quality and punishes its inefficiency. According to Hayek, the market provides benefits that have arisen by accident and not in a planned way. The real restriction of competition is imprisonment. Taxes and regulations must be minimized. Public services must be privatized. According to neoliberalism, collective agreements and the actions of trade unions distort the market. The market determines the hierarchy of winners and losers. Inequality is a generator of wealth and a reward for utility. It is the market that guarantees and provides everyone with what they deserve. On the one hand, the poor blame themselves, and according to neoliberalism, they must blame themselves for not being successful, for not being effective, for not being useful.

The fact that someone is unemployed means that the person is not enterprising, useless, has no real value and price to look for. In a world that is governed only by competition and the market, those who are not successful must look for guilt only in themselves, so they are losers. The term neolibarazil originated in 1938. At a meeting in Paris, attended by two of its representatives, Ludwig von Mises and Friedrich Hayek. In "The Road to Slavery" published in 1944. Hayek argues that "government planning crushing individualism will inevitably lead to totalitarian control. This is similar in Mises's book Bureaucracy." Mostly that the theses of these books attract the attention of rich people who begin to fund these theses. Hayek began to create a transatlantic network of academics, businessmen, journalists and activists, wealthy businessmen. While Hayek believes that governments must regulate competition to prevent monopolies, he gives in to Milton Friedman, who believes that monopoly power should be seen as a reward for efficiency. Hayek introduces his theory of spontaneous order into the market.

Ludwig von Mises and Friedrich von Hayek continue to be critical of the mainstream economy, even between the 1930s and 1970s. The economic crisis in the early 1970s gave rise to a new consideration of monetary theory and the theory of the economic business cycle. Therefore, they are looking for a solution that responds to inexplicable processes, which include high inflation and low employment. A turning point came in 1974, when Friedrich von Hayek won the Nobel Prize in Economics for his work on monetary theory and business cycle theory.

Hayek's analysis begins with the market. For Hayek, the market is an institution of spontaneous public order. Free spontaneously emerging markets and free will to exchange are interrelated and conditioned. According to Hayek, "freedom is a situation in which individuals do not depend on the arbitrariness of others. 1948 For Hayek, information and knowledge play an important role, they are the main driving forces of market processes. There is no perfect information to match the expectation with reality. According to Hayek, individuals adapt to the market and improve the conditions for themselves by improving the knowledge and information they have through the market itself. Regulation must take place only through the market itself and the market itself. Hayek further developed Leon Vapras's theory of market equilibrium, which he considered to be static with perfect information for market participants. According to Havek, equilibrium is a dynamic category due to incomplete awareness. But this lack of information is managed and controlled by monopolies and the oligarchy, which does not allow full market awareness. It is the mafia that controls the formation of the market. It makes awareness. The discrepancy between demand and supply is also due to incomplete information and incomplete information about the market. The mafia controls the flow of information. The mafia masters the information, there is no perfect information, they hide the information, they limit the access to information, they limit the information. Where neoliberalism cannot be imposed, its principles and programs and policies are enforced by so-called trade agreements by the World Trade Organization, imposing a system of dispute settlement mechanism between investors and states through offshore arbitration tribunals, whereby corporations can enforce countries to repeal social, environmental and other protections and regulations.

In fact, rents are growing faster than the increase in income. Costs grow faster than incomes. Separately, the rent grows faster than the monthly mortgage payment for the home purchased. Practically, wealth begins to melt and decline faster than income increases. 1968 The French almost overthrow President de Gaulle

BANKS create inequality in consumer mortgages. Norms and morality are falling inequality is increasing

Opportunity inequality - inequality of opportunity for expression - talent and more.

There is no equality of opportunity. Altar Laffer shows a leak of wealth.
