NORM is Bulgaria to be used only for money laundering, 30 to 50 percent of all investments in equipment, machinery, investments return to the company of EUROPE and Western countries.

NORMA is for prosecutors not to obey laws, prosecutors to appoint experts who serve the mafia and the prosecution and are ready to prepare any false expertise, a prosecutor to appoint an expert to prepare a graphological expertise, which is false and claims the opposite when the prosecutor influences the process and the evidence by appointing experts close to the mafia to prepare appraisal, accounting, graphological, psychiatric and other expertise accounting, as well as dependents who give obviously incorrect appraisals, such as appraisal of real estate prices 500 times above normal market prices.

NORMA is for a prosecutor to bring charges for a crime committed by another person by imputing crimes, which is contrary to the law and practice when the prosecutor does not respect international law.

NORM It is when the prosecutor deliberately misapplies the law, for example, the prosecutors Mariana Stankova, Yaneva, Dimitrova, Balev who accuse the PEA of selling properties, which she seized on 30.08.2007. of public sales in early 2008, provided that after the foreclosure on 30.08.2007. Kremikovtzi sold them to third parties on 02.112007. and 09.09.2007 despite the ban on property - ie. there is a proven crime by Kremikovtzi employees, but for these prosecutors this is not a crime - that of Kremikovtzi.

NORM IS when the prosecutor deliberately fails to enforce an effective court decision.

NORM Is when the prosecutor deliberately does not apply the law because the defendant is his fellow judge

NORM Is when the prosecutor deliberately does not respect the decrees of other institutions NRA, prosecutor's office for proven facts and circumstances.

NORM It is when the prosecutor does not even comment on indisputable collected written evidence prosecutor Yaneva, Dimitrova Stankova - payments by bank transfer.

NORM IS when the prosecutor orders the expert not to respect the law and not to comply with an effective decision

NORM It is when a prosecutor appoints experts and orders them to prepare accounting expertise and instead of complying with the law and setting prices for uncategorized land - soles - uncategorized land assessed by law and regulation at a price of BGN 40 per decare, sets prices from 18,000 to 28,000 BGN per decare - which is 450 TIMES OVER THE LEGAL and determination of non-categorized lands AS LPR for construction of 10-storey buildings. Prosecutors Mariana Stankova, Dimitrova, Yaneva.

THE NORM IS THE EXECUTION OF REPRESSION, COORDINATION, EXTORTION by prosecutors against citizens and companies that do not obey the executive branch - the Prime Minister and his racketeering and extortion to transfer property to companies.

NORM IS when prosecutors fabricate indictments with fabricated charges, or charges based on fraud and fake expert reports in violation of the laws of that country.

THE NORM IS WHEN PROSECUTORS OF THE CHIEF PROSECUTORS Assoc. Prof. BORIS VELCHEV, SOTIR TSATSAROV, IVAN GESHEV STRETCH AN UMBRELLA FOR COMMITTED CRIMES BY PRIME MINISTER SERGEY STANESYOV Z.

NORMA is an umbrella of the prosecutor's office with Chief Prosecutor SOTIR TSATSAROV and Chief Prosecutor IVAN GESHEV for stealing land from companies close to the mafia

NORMA is an umbrella over judges, ministers, prime ministers.

NORMA is an umbrella stretched, double standard by prosecutors Mariana Stankova, Ina Yaneva, Boyan Balev, Tsankov, Dimitrova of the Sofia City Prosecutor's Office over proven crimes of private bailiffs such as Georgi Dichev, Ivan Cholakov, Nedyalka Kovacheva, Stoyan Yakimov, Bazinski and Bazinski and Dezinski.

NORMA is an open umbrella over a judge of the Sofia City Court Yordanka BORISOVA MOLLOVA and her brother HRISTO BORISOV MOLLOV, who possessed and stole slot machines and bingo-awakening with losses of over 20 million USD.

NORMA is a tsar over notaries such as Rumen Dimitrov and dozens of others who have prepared notarial deeds based on the lack of documents, stolen owners, without signed contracts of sale.

NORMA An umbrella has been stretched by the prosecutors of FILCHEV, Assoc. Prof. BORIS VELCHEV, SOTIR TSATSAROV, IVAN GESHEV over mafia people like EMIL KYULEV, DONEV acquired fake deeds. It is NORM for the prosecutors of SOTIR TSATSAROV and IVAN GESHEV to stretch an umbrella over

judges whose cases worth hundreds of millions of euros have disappeared.

NORMA is ROKURORI INTENDED TO DELAY INVESTIGATIONS as prosecutor KYUVLIEVA in order to pass the statute of limitations and to end prosecutorial files for theft and fraud of money worth millions of euros.

NORM is the prosecutors of the chief prosecutors SOTIR TSATSAROV and IVAN GESHEV, prosecutor Boev refused to investigate persons WHO SELL ORIGINAL AMERICAN PASSPORTS AND AMERICAN DRIVERS FOR EUROS AND 15 DRIVERS FROM 15 EUROS.

It is NORM for the prosecutors of the Chief Prosecutors SOTIR TSATSAROV and IVAN GESHEV to stretch an umbrella over tax officials performing racketeering, REPERSIONS against CITIZENS AND COMPANIES WITH THE PURPOSE OF THEFT OF ASSETS, COMPANIES, PROPERTIES.

It is NORM for prosecutors to hold back on OVER PROVEN COMMITTED CRIMES of Prime Minister Boyko Borissov's ministers. Example Minister LILYANA PAVLOVA.

4. EVIDENCE AND EXAMPLES OF THE NEOLIBERAL NEOFASCIST MAFIA IN THE PROSECUTOR'S OFFICE UNDER THE CHIEF PROSECUTORS ASSOC. BORIS VELCHEV, FILCHEV, SOTIR TSATSAROV, IVAN GESHEV - IN BULGARIA AND THE FULL SUPPORT OF THIS MAFIA FROM THE EUROPEAN COMMISSION AND THE EUROPEAN UNION

4.1. Inaction of prosecutors from the Sofia City Prosecutor's Office and the Supreme Cassation Prosecutor's Office and personally informed SOTIR TSATSAROV to take action against the Prime Minister BOYKO BORISOV and his ministers for the following:

2010 A Council of Ministers with Prime Minister Boyko Borissov is giving private land on concession - a clear goal - - caused losses of more than \$ 5 billion in investment, lost profits and profits. No investigation by the Prime Minister and the ministers responsible for this.

Council of Ministers with Prime Minister SERGEY STANISHEV 2009 and then 2010 with Prime Minister BOYKO BORISOV has taken a DECISION OF THE COUNCIL OF MINISTERS № 43 FROM 23.01.2009, DECISION № 69 FROM 15.02.2010 and has concluded an illegal concession ON PART OF PROPERTIES,

and has determined and finally added 2 PART 928.5 in the amount of an additional area of 9,084 decares PRIVATE PROPERTY.

On April 3, 2013, the CHIEF PROSECUTOR SOTIR TSATSAROV was appointed APPOINTMENT, according to the City Prosecutor of SOFIA Kokinov, to be the Prosecutor General for the establishment of criminal proceedings against the persons - former Ministers of Economy Tr., Miroslav Katsarov, and Prime Minister BOYKO BORISOV For an obvious and proven crime - GIVING PRIVATE LAND on concession - in violation of all laws.

NEITHER THE COUNCIL OF MINISTERS, AS PERSONALLY THE MINISTER - THE PRESIDENTS Sergey STANISHEV AND BOYKO BORISO, HAVE NOT TAKEN ANY MEASURES AND ACTIONS. Neither the CHIEF PROSECUTOR SOTIR TSATSAROV nor GESHEV.

Damages caused - losses from INVESTMENTS And over 5,000,000,000 / five billion / USD.

4.2./. DOUBLE, TRIPLE STANDARD, STRETCHED UMBRELLA by the prosecutors of the Chief Prosecutor SOTIR TSATSAROV, and IVAN GESHEV over judges, MINISTERS, PRIME MINISTERS. STRETCHED UMBRELLA

Inaction of the prosecutors and personally informed the Chief Prosecutor SOTIR TSATSAROV for inaction of the Prime Minister Boyko Borissov and Ministers of Transport in connection with huge obligations of the state company "Bulgarian Posts" EAD and failure to know the laws of this country. lost billions

Attached to the CHIEF PROSECUTOR SOTIR TSATSAROV - evidence attached to the Prime Minister Boyko Borissov, Minister Moskovski, Minister Tsvetkov and so on dozens of EVIDENCES since 2010. because the Ministers of Transport of BOYKO BORISOV do not comply with the laws of the Republic of Bulgaria - the Commercial Law, the Law on Obligations and Contracts in connection, the Articles of Association of "Bulgarian Posts" EAD as a principal in connection with the proven under item 1456/2005 obligation of Bulgarian Posts EAD to Goldman Management LLC and the actual non-fulfillment of Art. 295 para 1 of the Commercial Law, art. 2 of the Articles of Association of Bulgarian Posts EAD Art. 187E of the Commercial Language, Art. 130, 131 and 132 of the Law on Obligations and Contracts for Transfer of 95% of the Shares of Bulgarian Posts EAD to Goldman Management LLC.

Indisputable evidence was attached to the Chief Prosecutor SOTIR TSATSAROV that judges from the Supreme Court of Cassation - Tanya Raykovska, Daria Prodanova, Totka Kalcheva, Nikola Hitrov, Eleonora Chanacheva, Emil Markov from the Supreme Court of Cassation - judges from Glozhenska, Bozhikov, Spasov from Plovdiv violate the Bulgarian and European laws deliberate violation of the mandatory directive 2008/6 / EU of the European Union and the European Commission from 01.01.2010. according to which from 01.01.2011 The state company Bulgarian Posts EAD does not have a monopoly on its activities, and the same monopoly has been revoked on January 1, 2011. and the real causes are losses in a particularly large amount, fulfilling an order of the executive branch.

The same judges allow themselves under item 519/2012 of the Supreme Court of Cassation, under case file 798/2011, case file 689/2011, of the Court of Appeal Plovdiv, under case file no. 3765/2013 to confirm the termination of the bankruptcy case of the company "Bulgarian Posts" EAD for its obligation in the amount of over 100 000 000 / one hundred billion / euros, and actually in addition to violating the law and caused the above huge loss , CARRIED OUT ONLY IN FAVOR OF THE STATE MAFIA, IN FAVOR OF CRIMINAL ACTIONS OF MINISTERS, EXECUTIVE DIRECTORS OF THE STATE FIRM FIRM.

EVEN MORE, THAT THE JUDGES OF THE SCC HAVE MADE A DETERMINATION WHICH PROVES A VIOLATION OF THE LAW, SINCE 01.01.2011. BULGARIAN POSTS EAD DOES NOT HAVE A MONOPOLY ON ITS ACTIVITIES, AND THE SAME MONOPOLY HAS BEEN ABOLISHED AS OF JANUARY 1, 2011. by the EUROPEAN COMMISSION.

SEPARATELY FROM THIS ACCORDING TO THE DIRECTIVE OF THE EUROPEAN UNION, WHICH IS MANDATORY FROM 01.01.2010. THE MONOPOLY OF THE COMPANY BULGARIAN POSTS EAD HAS BEEN REMOVED.

THIS DIRECTIVE IS MANDATORY TO ALL BULGARIAN JUDGES. LOSS FOR AT LEAST 100 BILLION EUROS.

4.3 /. DOUBLE, TRIPLE STANDARD CONCERNING PROVEN CRIMES ABOUT MINISTERS, PEAS IN FAVOR OF PRIVATE COMPANIES

Inaction of the Prime Minister Boyko Borissov and the prosecutors and the Prosecutor General - personally notified of the participation of the Minister of the Ministry of Regional Development and Public Works in the

sale of GUSV properties at prices 3-5 times below the tax assessment of third parties and the participation of the Ministry of Regional Development GUSV in fraud and theft of property for millions and receiving millions against an obligation of only GUSV of BGN 249,000 and the fraudulent schemes of the person K.A.M. The PEA people of the GERB MAFIA have damaged the state with OVER 18 million euros, and instead of transferring them to the BUDGET OF THE STATE, ie. of the NRA, this money went into private pockets. The prosecutors from the specialized prosecutor's office Staninska, Toncheva, Hristova, Kamenov, and dozens of others refused to be criminally convicted and actually committed crimes of the PEAs damaging the budget by over 18 million euros. for tens of millions of euros, an umbrella has actually been stretched over the PEAs, the mafia close to the government, as well as private companies.

The inaction of prosecutors and personally informed Sotir TSATSAROV and IVAN GESHEV, who despite protocols of the State Gambling Commission from 2006 and 2008 found their own slot machines ibingo equipment in the property of former Sofia City Court judge Yordanka Borisova Mollova and her brother - former trustee of Avivi Balkan "Hristo MOLLOV in the village of Gorsko Novo Selo and their failure to file a criminal case for seizure and theft - losses of over 14 million euros against the former judge of the SOFIA CITY COURT and her brother - the former trustee of Balkan Airlines.

Ie EVIDENCE stretched by an umbrella by the Chief Prosecutor SOTIR TSATSAROV and his prosecutors over Yordanka Mollova and her brother and the prosecutors of the Chief Prosecutor IVAN GESHEV.

4.5./. PROVEN DOUBLE, EVEN TRIPLE STANDARD, OBVIOUSLY TIGHTENED UMBRELLA by the prosecutors of SOTIR TSATSAROV and IVAN GESHEV - prosecutor Mariana Stankova, Dochev, Nina Yaneva, Boyan Balev, Georgi ChatenI Ivan ChIenI To Ivandev ChI ToniV Nedyalka Kovacheva

The inaction in 2009 of prosecutors from SGP and personally SOTIR TSATSAROV and personally informed the Chief Prosecutor IVAN GESHEV about the illegal actions against Private Bailiff Georgi Dichev returned money to a buyer who bought a property, and practically ensured the burying of property for millions of levs alone and only 150,000 levs. PROVEN BY PROSECUTOR DOCHEV and by Procurator NINA YANEVA. . THERE IS NO REACTION AND ACTION TO PROCEED A CRIMINAL CASE AGAINST PEOPLE DICHEV FROM PROSECUTORS DOCHEV AND NINA YANEVA - AS THEY ARE FROM THE MAFIA AND BENEFIT FROM THE PROTECTION DIRECTLY TO THE CHIEF PROSECUTOR. In ONE MOMENT, Dichev stated that he had transferred the debtor's money of BGN 706,000 to a bank account in the Corporate Commercial Bank. After it turns out that the debtor company does not have such a bank account, PEA Dichev states that the debtor has requested that the money be transferred to the creditor - to return the money that belongs to him over BGN 706 thousand. AS A RESULT, PEA Dichev SELLS A PROPERTY to a creditor at a sale price of over BGN 800,000 only for a claim of BGN 150,000 and returns the money he has "paid" for the property. .e. THEFT OF PROPERTY, WHICH COSTS MILLIONS OF BGN, IS LEGALIZED. THE TENSIONED UMBRELLA IS STILL SINCE 2009.

4.6./. DOUBLE, EVEN TRIPLE STANDARD, OPENT UMBRELLA OVER OBVIOUSLY PROVEN VIOLATIONS OF PEA YAKIMOV

The inaction of 2009 prosecutors from the SGP and personally notified Chief Prosecutor Sotir Tsatsarov to support actions - appropriation and use of official position by Private Bailiff Stoyan Yakimov - in dozens of enforcement cases - .

4.7./. A stretched umbrella, double and triple standard in a prosecutor's office, which does not actually investigate the press of Emil Kyulev's property through a notary Rumen Dimitrov for zero pennies, properties worth over 600 million euros, real own heirs and the owners of insurance companies before 1944. this inaction and TENSIONED UMBRELLA AND MILITARY, EVEN TRIPLE STANDARD IS SINCE 2005. AND CONTINUES UNTIL TIME

The same applies to a property that DONEV has acquired with a statement of property in the center of Sofia on St. Sofia Street, which is the property of the heirs of an insurance company.

The inaction of the prosecutor and the chief prosecutor Sotir Tsatsarov and personally informed the chief prosecutor IVAN GESHEV to prove thefts for zero stotinki of properties for over 500 million euros on the basis of notes issued for zero stotinki. Acts of Emil Kyulev by notaries R. Dimitrov et al., And stolen heirs of insurance companies - stolen property in the center of Sophie for 500 million euros. Despite dozens of signals about the illegal actions of the mayor of SOFIA 2007 and the inaction of Mayor FANDAKOVA, who does not

want and does not want to EXECUTE a JUDGMENT of the Supreme Administrative Court, according to which the heirs of "Zemedelets", "Balkan", "Balkan Life" and others in the center of Sofia, 1 Positano Street, 10 St. Sofia Street, 6 Tsar Osvoboditel Blvd. - a building with an area of over 11,500 sq.m. 75 - 77 Maria Luiza Blvd., 39 Bergalnitsa Blvd. and dozens of other properties. sold them to third parties - DESPITE THE DECISION OF THE SUPREME ADMINISTRATIVE COURT. insurance companies. IN ORDER TO STOLE THESE PROPERTIES FROM PEOPLE AND COMPANIES CLOSE TO THE COAT OF ARMS.

Losses of over EUR 500,000,000 losses on the value of our properties, EUR 70,000,000 - lost profits and profits caused, BGN 5 million caused non-property damages - ruined health.

4.8./. STRENGTHENED UMBRELLA FROM THE PROSECUTOR'S OFFICE OVER JUDGES AND HEADS OF COURTS, CRIMINAL LAWLESSNESS AND CRIMINAL INACTION, DOUBLE STANDARDS,

The inaction of prosecutors and personally informed SOTIR TSATSAROV about our missing cases over 390 cases in the Sofia City Court and the SRS - won at first instance and others since 2005. due to the petition of a former judge from the Sofia City Court. Losses of over 800 million euros.

4.9./. The same judges allow themselves under item 519/2012 of the Supreme Court of Cassation, under case file 798/2011, case file 689/2011, of the Court of Appeal Plovdiv, under case file no. 3765/2013 to confirm the termination of the bankruptcy case of the company "Bulgarian Posts" EAD for its liability in the amount of over 50 000 000 000 / fifty billion / euros, and actually in addition to violating the law and caused the above huge loss , CARRIED OUT ONLY IN FAVOR OF THE STATE MAFIA, IN FAVOR OF CRIMINAL ACTIONS OF MINISTERS, EXECUTIVE DIRECTORS OF THE STATE FIRM "FIRM".

Despite the signal from 2004 during the time of Chief Prosecutor FILCHEV, then the signal disappeared with Chief Prosecutor Assoc. Prof. BORIS VELCHEV, disappeared with Chief Prosecutor SOTIR TSATSAROV and Chief Prosecutor IVAN GESHEV.

The signal for the irregularities of the judges to the prosecutor's office disappears. LOSSES OVER 250 BILLION AND US DOLLARS On July 23, 2019 Deputy Chief Prosecutor IVAN GESHEV - Head of the Specialized Appellate Prosecutor's Office has received a complaint with a SIGNAL COMPLAINT for obvious use of official position and a request for immediate action and indictment and a proposal for immediate dismissal of judges from the Supreme Administrative Court. 4696/2014 - 4th Division Judge Galina Mateyska, Judge Todor Petrov Judge Svetoslav Slavov as well as LEGALIZED a GROSS VIOLATION OF THE LAW by the MINISTRY COUNCIL - GRANTING A CONCESSION TO PRIVATE LAND IN ADVENCE AND AD / 2014 - five-member panel, Judge Yordan Konstantinov, Judge Fani Naydenova, Judge Marusya Dimitrova, Judge Blagovesta Lipcheva, Judge Stefka Kemalova

A request was made by the Supreme Judicial Council for the immediate dismissal of the eight administrative judges. He was then referred to the CHIEF PROSECUTOR IVAN GESHEV after he became Chief Prosecutor for the obvious use of official position by the eight administrative judges.

THERE IS NO REACTION, NO COMPLIANCE WITH THE LAW, NO ENFORCEMENT OF THE LAW, PUBLIC SUPPORT OF THE PROSECUTOR'S OFFICE AND THE JUDICIAL SYSTEM OF THE MAFIA IN THE MAFIA

The ombudsman of the Republic of Bulgaria, Mr. KONSTANTIN PENCHEV, was also accused of the illegal concession on July 23, 2015. NO REACTION. NO ACTION.

6. THE PROSECUTORS OF THE CHIEF PROSECUTOR SOTIR TSATSAROV AND THE CHIEF PROSECUTOR IVAN GESHEV LEGITIMIZE OPENLY AND PROVEN CRIMES COMMITTED BY DEPUTY. THE PRESIDENT OF THE SUPREME COURT OF CASSATION KRASIMIR VLAHOV - NOW A CONSTITUTIONAL JUDGE

The Deputy Chairman of the Supreme Court of Cassation, KRASIMIR VLAHOV, in violation of the law, himself appoints judges to hear cases without using the electronic system for random selection. He has been doing it for more than 6 / six / years. There are days when he appoints judges in 30-40 cases in the Supreme Court of Cassation.

According to Resolved is N_{2} 46 / 07.08.2019. of the Supreme Judicial Council on the application for access to public information reg. N_{2} 46 / 24.-07.2019 is allowed to provide full access, CONFIRMING that Judge Krassimir Vlahov did not participate in the competition for the promotion of judges to the Supreme Court of Cassation. He was appointed by a decision of the SJC under protocol N_{2} 14 / 05.04.2012. for "Deputy Administrative Head - Deputy Chairman" of the Supreme Court of Cassation on the proposal of the President of the Court.

The procedure for election of the Chairman of the Supreme Administrative Court, in which Georgi Kolev participated, was terminated by a decision under protocol N_{0} 38 of 21.10.2010. of the SJC, and Georgi Kolev was elected chairman of the SJC by a decision of the SJC under protocol N_{0} 42 of 15.11.2010. He was appointed to the position by Decree N_{0} 311 / 17.11.2010.

Ie the above proves that ALL JUDICIAL ACTS SIGNED BY JUDGE Krassimir Vlahov are null and void - ie. since 2012 as he has never and in no way participated in a competition for a judge in the Supreme Court of Cassation and has not been elected in such a competition for a judge of the Supreme Court of Cassation.

Although in the distant 2012-2013 the chairman of the Supreme Court of Cassation Prof. LAZAR GRUEV was informed about the above, he did not take any action.

Although the SUPREME JUDICIAL COUNCIL and all its members Georgi CHOLAKOV, Atanaska Disheva, Boryana Dimitrova, Krasimi Shekerdzhiev, Olga Karelska, SEVDALIN MAVROV, Tsvetanka Pashkunova, Boyan Magdalinchev, Bonika Ivavaya, Marian Kovava, Vero Ivacheva, Vero Novava, Vero Novaski, Vero FOR THIS LAWLESSNESS of the then judge KRASIMIR VLAHOV - they did not take any action for his dismissal. He is ALREADY A CONSTITUTIONAL JUDGE, so even after President RUMEN RADEV was informed of these irregularities by the judge, he confirmed him as a constitutional judge.

Although the Chief Prosecutor SOTIR TSATSAROV and the Chief Prosecutor IVAN GESHEV were informed about these illegal actions by Krassimir VLAHOV, there are no actions from the Prosecutor's Office.

On the other hand, Krassimir Vlahov appoints judges with his Orders on specific cases, as they must be decided in favor of the Mafia and cause losses to HUNDREDS OF MILLIONS OF EUROS.

Judge Krassimir Vlahov in the distant 2013 on chgrd. 1252/13 1253/13 and 1254/13 appoints EXACTLY DETERMINED THREE SAME JUDGES in three different cases and private appeals in pending cases for a claim of 121 million euros against the Sofia Municipality with MAYOR BOYKO BORISOV and FO.

On the other hand, Judge KRASIMIR VLAHOD with an Order from October 2017. appoints dozens of judges in specific cases without using the random selection system.

In reality, the Supreme Court of Cassation is legalizing the theft of property of MAFIA companies, the theft of property in favor of third parties, the theft of property committed by SAS judges in favor of third parties, the legalization of REPRESSION - REPRESSION of RAINA Martinova confirmed by the judges of the Supreme Court of Cassation, cited above.

In reality, the Supreme Court of Cassation is legalizing the TERMINATION OF ALL CASES FOR THE THEFUL AN EMIL KYULEV of properties of the heirs of insurance companies - PROPERTIES FOR OVER 600 MILLION EUROS - apparently in the order of the mafia.

In reality, the Supreme Court of Cassation legitimizes all terminations of cases ordered by the MAFIA and terminated at the first hearing in the SCC, SCC, KOS, VOS, MES, Vidin District Court and other courts.

The prosecutors of the Chief Prosecutor SOTIR TSATSROV and the current Chief Prosecutor IVAN GESHEV and the prosecutors from the Specialized Prosecutor's Office have stretched an UMBRELLA OF THE SIDES Vladimir Valkov, Maria Boycheva iml. Judge Desislava Yordanova WHO LEGALIZE THEFT OF PRIVATE PROPERTY IN FAVOR OF MUNICIPALITY OF CAPITAL.

DECISION of 02.09.2019 of the judges Vladimir Valkov, Maria Boycheva and Jr. Judge Desislava from the Sofia City Court under gr.d. 10481/2009

In violation of the law and the evidence, the judges do not cite, do not respect, do not even mention the following facts and evidence in the case:

Decision № 178 ogt 13.01.2004 of the Supreme Administrative Court under Adm. Case 5159/2003, entered into force, by which the SAC explicitly decrees that the MUNICIPALITY OF CAPITAL is not the OWNER of the entire property at 1 Positano Street, Sofia - building - three-storey, shops and land. Explicitly in the reasoning of the Supreme Administrative Court is the fact that the property belongs to the heirs of the owners of the insurance company, owner of the property before 1944.

Nevertheless, a decision came into force on 19.02.2004. Judges VALKOV, YORDANOVA and BOYCHEVA mixed the current Law on Cooperatives, where there are no shares, with the LAW ON COOPERATIVE ASSOCIATIONS of February 17, 1907. ?!?!

Judges VLADIMIR VALKOV, YORDANOVA and MARIYA BOYCHEVA CONSCIOUSLY confuse and CONSCIOUSLY DISREGARD THE OWNERSHIP OWNERSHIP OF OUR HEIR in the company Musala - Zemya. attached to the present case FROM WHICH IT IS SHOWN THAT THE INHERITANCE HAS SHARES OF 1464 shares / one thousand four hundred and sixty-four8 / out of a total of 5646 / five thousand six hundred and forty-six / shares or this makes 25,929 PERCENT / twenty-five percent of 9.5 percent SHARES OF THE CAPITAL OF THE COMPANY?!?!

Judges VALKOV YORDANOVA and BOYCHEVA do not even mention this indisputable PROVEN FACT. There is an obvious and proven art. 282 of the Criminal Code.

The Presidents of the Sofia City Court - Judge Alexei Trifonov and the former Presidents Kaloyan Topalov, Popkoleva, of the Sofia Court of Appeal - Judge Daniela Doncheva and the Supreme Court of Cassation and the President of the Supreme Court of Cassation Prof. Lazar Gruev have been repeatedly informed of illegal actions. their judges, as a small part of the cited examples of all judges cited so far in this article, by their courts and they were asked to fulfill their obligations under Art. 312 of the Judiciary Act - WITHOUT RESULT. NOTHING!?!?! In reality, they do not comply with the laws of this country, to demand disciplinary punishment for the lawlessness of their subordinate judges.

PARTS OF THE PROPERTY OF D.'S COMPANIES IN THE AMOUNT OF 253 DECARES ARE TAKEN OUT AND THESE PROPERTIES ARE REGISTERED AS PROPERTY OF SOFIA MUNICIPALITY - WHICH IS A LIVING THEFT OF PRIVATE PROPERTIES, WHICH IS NOT REALLY THE OWNER OF THEIR PROPERTIES AND IS ACTUALLY REALIZED THROUGH THE OFFICE OF CADASTRE THEFT OF PRIVATE PROPERTY FOR THE BENEFIT OF THE CITY MUNICIPALITY.

By Order № 18-5904-30.06.2020 of the head of SGKK Sofia eng. Momchil Terziiski, was approved APPROVED amendment of the cadastral map and cadastral registers in the village of Lokorsko in eliminating a clear factual error for drawing land with draft identifiers.

The property of D.'s company, which was previously 2050,888 decares, suddenly became 1797,286 decares - ie. there is a theft of properties ILLEGALLY TRANSMITTED AS OWNERSHIP OF THE CITY MUNICIPALITY, namely seven properties.
